4. The Delivery schedule of the Supply and Delivery of Conductor Wires of Various sizes and lengths for use in relocation, construction, and maintenance will be made within 30-45 days after receipt of the Notice to Proceed.
5. LANECO will hold a Pre-Bid Conference (date and time stated above) which will be opened to all interested parties who have purchased bidding documents. Attendees to the pre-bid conference are only the prospective bidders or their authorized representative (through a written authorization duly notarized and valid I.D.).
6. Bids must be submitted to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security.
7. The Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the implementing Rules and Regulation (IRR) of the Republic Act (RA) 10531.
8. Interested Bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below during office hour, Monday to Friday before the opening of Bids.
